Thank you for your interest in Wild Futures European Solidarity Corps Project

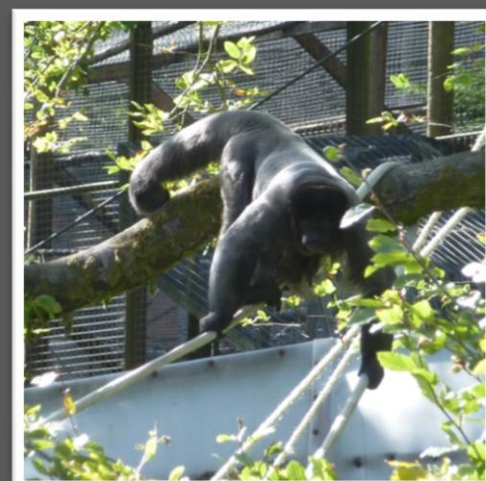
The European Solidarity Corps is the new European Commission initiative which creates opportunities for young people to volunteer in projects in their own country or abroad that benefit communities and people around Europe. As the programme is covered by the European Commission the projects are completely free to volunteers! This includes:

- Full coverage of food and accommodation
- Travel expenses to and from the UK (with a maximum limit)
- Complete health insurance for the entire period of your volunteer stay
- Language training for long term non-native speaking volunteers.

There are **short term** placements for 2 weeks, 4 weeks and 8 weeks throughout the year for UK and non- UK volunteers.

Long term placements run for 12 months and start every October. Volunteers can choose from a range of placements in which their project will focus in: **Primate Care x 4** (3 UK and 3 non-UK participants) , **Admin x 1** and **Site and Sustainability x 1** and **Volunteer Coordinator Assistant**.

You can only submit a long term application in June; we hope to find all volunteers by the end of the month.

Wild Futures

Wild Futures is the only UK charity with a holistic approach combining an educational and environmental remit dedicated to promoting the welfare, conservation and survival of our closest living relatives, the non-human primates. We are working to end the primate trade and abuse of primates in captivity, promoting the rehabilitation of captive primates and the preservation of those in the wild, whilst operating a sanctuary for primates in need of a home for life.

Our safe haven for monkeys saved from mistreatment is The Monkey Sanctuary, in Cornwall, UK. We recently celebrated our 50th Anniversary and have provided a home for life and specialist care for more than 160 monkeys over the years. We are proud to be the first and only facility in the whole of Europe to be accredited by the Global Federation of Animal Sanctuaries (GFAS), demonstrating that we provide humane and responsible care for our animals. Because most of the monkeys come into us extremely traumatized and damaged, we recognize the importance of ensuring long-term, consistent care from people they know and trust. We also rely heavily on volunteers to help us to run our sanctuary day-to-day.

As well as providing a home for life to monkeys in need, we work closely with other charitable organizations to lobby local and central government to try and bring about positive change for primates. Our campaigns work has led to much advancement, including political recognition of the trade in primates as pets, the publication of a primate code of practice as part of the Animal Welfare Act 2006 and strong public support demonstrated by 45,000 petition signatures. We believe that education is vital for change and act in an advisory capacity in diverse forums, as well as educating visitors to our sanctuary and more than 3,000 school, college and university students on our work each year. We are committed to providing advice, practical support and funding to overseas projects linked with primate welfare and conservation. We have supported primate projects throughout South and Central America and Africa, many of which involve conservation initiatives with local communities and government.

When it comes to conservation though, we believe it's just as important to conserve plant and animal species closer to home as those on distant shores, so we also work to conserve UK species in danger from habitat loss, including the lesser horseshoe bat and the pearl-bordered fritillary butterfly.



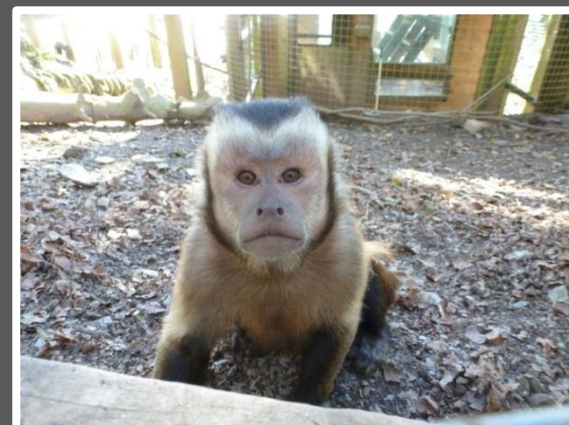
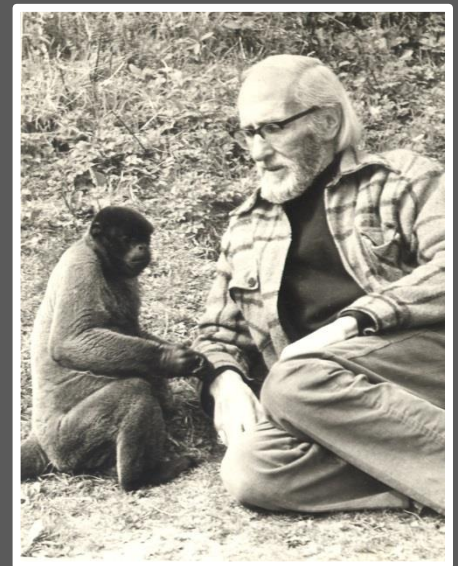

The Monkey Sanctuary, past and present

The Monkey Sanctuary was established in 1964 by Leonard Williams and a team of co-workers. It began as a refuge for ex-pet and ex-zoo woolly monkeys, receiving recognition as the first place where this species bred outside its own habitat in the South American rainforests. Since the beginning, the aims of the sanctuary have evolved to focus on the protection of habitats and primates in the wild, native wildlife conservation, the rescue and rehabilitation of ex-pet monkeys and campaigning to end both the illegal and legal primate pet trades. The sanctuary became a registered charity under the name 'The Monkey Sanctuary Trust' in 2004 and in 2009 the name 'Wild Futures' was chosen to reflect the wider aims of the charity. Today we are home to 6 woolly monkeys, all descended from those rescued in the Sanctuary's beginnings, 3 Barbary macaques and 28 capuchins.

The Sanctuary is open to the public during the summer months. As well as carrying out the day to day care of the monkeys, the monkey carers give talks to the public about the individual monkeys, the wider issues surrounding the primate pet trade, global wildlife conservation and sustainability. The team have their own specialist areas of work such as maintenance, campaigns, education and fundraising. The Wild Futures' team share concern for animal welfare, conservation and global environmental issues.

Explaining the rota

The rota is a basic example of **some** of the activities which occur in each project. The rota will be planned on your arrival between you and your supervisor.

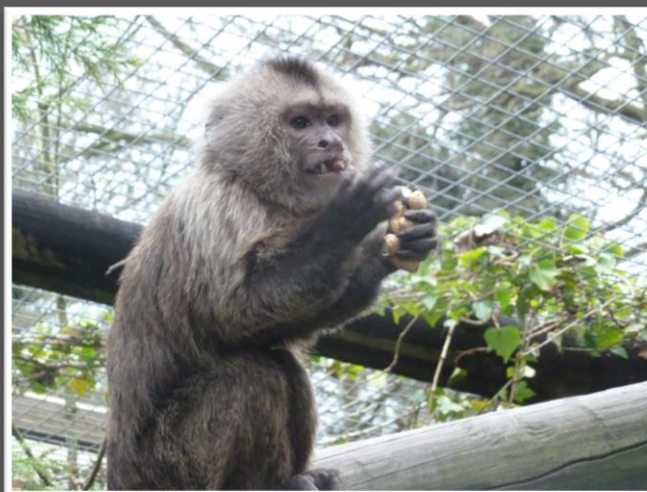
ALL long term volunteers will conduct one month of normal volunteer work before focusing in on the chosen department (please see short term rota for the type of work). This is so that all volunteers gain an insight into the amount of work needed to keep the sanctuary functioning.

Much of the work is labour intensive and can be monotonous such as gardening, painting and cleaning.

Volunteers must know their project well before applying.

All volunteers **MUST** have a good level of English to participate (at least a level B) This is also vital due to the close proximity to dangerous animals. Long term volunteers may need it for public talks or speaking on the telephone.

Qualifications are not required, however previous experience is desirable.

Eligibility Criteria and Profile of the Volunteer.

Basic requirements: **18-30 years old**, volunteers from the UK **must** be resident in the eligibility areas (please see Eligible areas UK participants document), while non-UK volunteers must come from an eligible country (please see Eligible countries for non-UK participants document).

Previous funded placements

You **cannot** apply for an ESC funded **short-term** placement if you have already completed a long or short-term ESC or Erasmus funded placement in the past. You **can** however, apply for a **long-term** placement if you have completed a short term placement in the past. If you are unsure if you are eligible please email the Volunteer Coordinator.

Work experience for university or college.

You cannot apply for **any** ESC funded placement **as part** of a formal work experience module at your college or university. It has to be voluntary, and not part of a compulsory element needed to fulfill and complete the course you are on. Please email if you are unsure about this requirement.

Clear communication

Being able to speak good English (at least a level B) is important for your own safety and that of your colleagues. As an ESC volunteer, you will work with potentially dangerous animals. If the volunteer does not speak English well, we will have problems communicating.

Motivation

You must be fully committed when applying for these projects! It takes a huge amount of background work to organize volunteers to participate. If you accept a project and then drop out you causes a lot of disruption, loss of money and extra work. To protect against this, all volunteers must pay a £50 deposit to secure their placement. If you drop out before the start of the placement **this will not be refunded**. Please consider this carefully before applying! For long term volunteers, you must stay motivated for the entire year, make sure you understand and know the project before applying.

Hard working

This ESC project involves **a lot** of physical work. Up to 60% of the work will involve cleaning, be it the monkey rooms or the public areas. Unfortunately we cannot make exceptions as to the amount of cleaning, that is why you need to be passionate about the animals and the organization otherwise you will not enjoy this EVS experience. Volunteers should be generally physically fit, healthy and have an enthusiasm for hard work.

Affinity towards animals

Having an affinity to animals is important to understand why people work hard for the primates. Most animals show signs of trauma and need to be re-socialized with members of their own kind. We have a **'hands off policy'**, so the interaction between the caretaker and the animal should always be minimal. The fact that the animals develop towards a more natural life should be the cause of satisfaction.

No allergies

Having allergies for animal fur or peanuts is problematic as you have to be around these on a daily basis. In addition The house you may live in is a 19th Century Victorian house so please be aware that this old house comes with some problems (some dust, creaky floors)

Accommodation and Living

For volunteers staying 12 months, accommodation will be in a shared room with one other volunteer, or they will live privately on their own, or in a static caravan. Both types of accommodation are dependent on what is available at the time, so cannot be chosen by the volunteer. The accommodation provided is situated on site.

Short term volunteers will stay in one of our two dorm rooms which can house up to 5 people. This room is located in the main house on site. We try and keep male and female volunteers, however if this cannot be helped, you will be asked prior to your arrival if you are happy to share a dorm with the opposite sex.

A full house with short and long term volunteers with staff can reach up to 20 people living on site. **You must ensure you are mentally robust enough to cope with the living conditions.**

The house is a 19th century building which serves not only as the headquarters of Wild Futures but also a living space for both keepers and volunteers. Volunteers who live in the house or in the caravans have access to the communal areas and facilities which include:

Kitchen, bathroom, laundry room, T.V and lounge, drying room and gardens.

Wifi is available but please be aware that because of our rural location the broadband width is limited and Wifi can therefore be slow. Volunteers are welcome to use the office computers after work hours if needed.

Volunteers DO NOT pay for their accommodation.

This is a **vegetarian and vegan** household and **basic food** is provided. This includes things such as all vegetables, milk, bread, pasta, rice, cereals, pulses, fruit, jams, condiments, hot and cold drinks. As a volunteer we provide enough food and variety to eat all your meals and snacks, however, if you choose to buy more luxury foods such as chocolate, alcohol etc then there are shops in the next village. Please do not store, cook or consume any meat products within the house.

Pocket Money

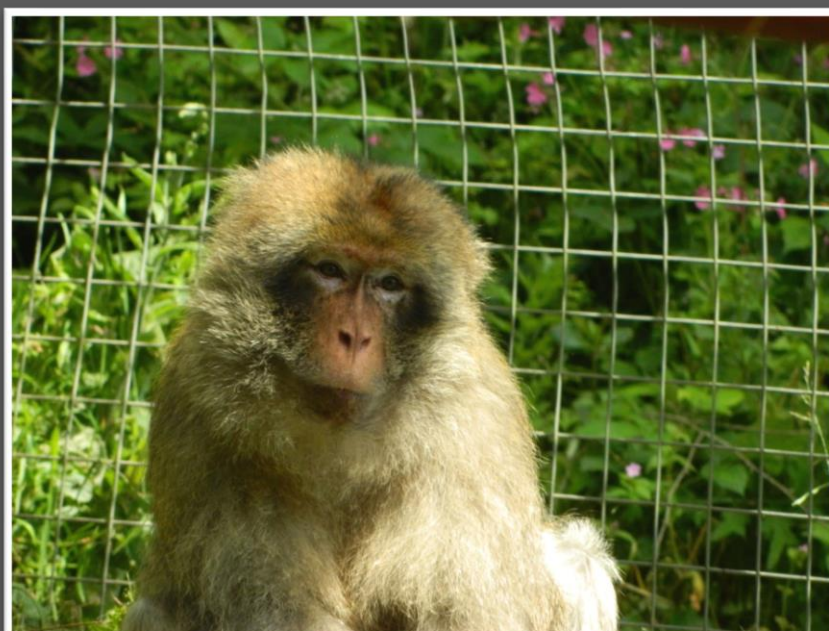
Pocket money is set at 6 euros a day which is converted using the European Commission own Exchange Rate website. This works out as £5.13 a day.

Please Note: We do not pay volunteers until they have stayed 14 days, this is to protect the sanctuary. If we pay you and you decide to leave before two weeks, it is not classed as an ESC placement and this will mean the charity will not be reimbursed the money we gave you. All two week volunteers will be paid on their last working day.

Money to all UK volunteers are paid into their UK bank accounts, so you will be asked to fill in a Bank Details Form after accepting a placement.

All non-UK volunteers are asked to register for a Revolut account. Your money will then be paid into this account.

All volunteers must ensure they have enough money, as you could be waiting from 2-4 weeks for your travel reimbursement, deposit and pocket money. We **CANNOT** give out money early so please ensure you bring plenty of money with you.

Travel expenses.

Volunteers from the UK have up to **£154** (180 Euros) to send on travel to the sanctuary.

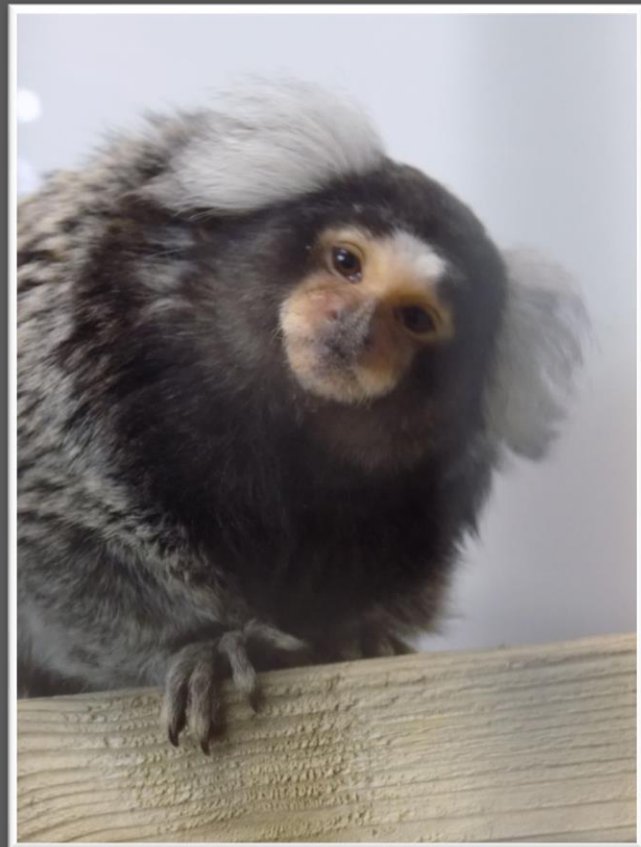
Non-UK volunteers have up to **£235** (275 Euros).

For both UK and non-UK volunteers, the money is for your travel to the sanctuary **AND** back home again. If you exceed this amount, you will have to pay the extra yourself. In addition, if you lose travel confirmation emails or receipts, then we cannot reimburse you either. Screen shots of receipts are **NOT** acceptable. We need proof of purchase to reimburse you, so please ensure you keep everything.

If you fly into the UK from another country, other than your own, we cannot be reimbursed. So for example, if you live in Italy, you must fly from Italy otherwise your travel will not be covered.

You will be asked to send all travel confirmation emails to the ESC Coordinator once you have bought them. This is so we have an electronic copy of your travel. All travel confirmation emails **must** have your name or email address, the dates of travel **AND** the amount you paid. We cannot accept a document that is missing any of this information so please ensure you check everything is there before sending it.

Travel reimbursement will be given out 2 after your arrival.

Deposit

As a way of safe guarding the charity we ask volunteers to pay a £50 deposit within 3 weeks as an additional way of securing your placement. This deposit will be returned to you once you have arrived, along with your travel reimbursement and pocket money. We ask this as we have found in the pass, that some volunteers have accepted placements but later decline them. For the volunteer there is no consequence however, for the charity we have spent hours of work trying to organise the arrival of that volunteer, not only with the volunteer, but with their sending organisation and with the National Agency. We also are dependent on volunteers to keep the sanctuary working, so when we book you in we are expecting to have a set amount of volunteers for that month. By dropping out means we do not have the right amount of volunteers to ensure all aspect of work is covered.

The deposit will be kept in the event of the volunteer declining their project. This will be to cover the administrative time spent.

No placement is confirmed until a donation has been made. This donation must be made within 3 weeks of the "Accepted Information" email. After this, we will presume you do not want your placement anymore, so you will be automatically cancelled.



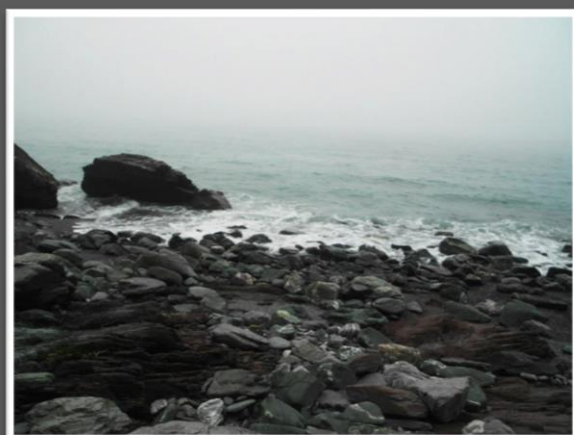
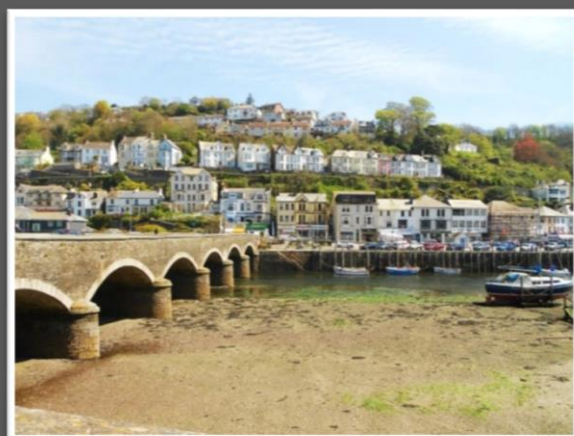

Free time

The surrounding countryside is picturesque. The Sanctuary is in a quiet rural area with access to the coastal path nearby. If you are prepared to walk, Looe and the nearby coastal villages of Seaton and Downderry are reachable within an hour. Looe is a tourist town and fishing port and is busy with holidaymakers in the summer. Looe offers souvenir shops, cafes, restaurants, pubs and walks along the coast or riverside. Boat trips are available to destinations such as Polperro (picturesque harbour village), Fowey, Looe Island (nature reserve) or along the Looe River. The nearest city of Plymouth which is 20 miles away, has bus and train connections from Looe. Other activities include visiting nearby Eden Project and Carnglaze Caverns. During winter, volunteers enjoy watching films and playing games by the fire.
